House Bills

Congressional Freethought Caucus Membership:

Founded in 2018, the CFC strives to protect the secular character of our government by upholding the separation of church and state in debate and legislation, and it promotes policy solutions grounded in reason and science.

The Supreme Court Ethics, Recusal and Transparency Act (SCERT):

The Supreme Court Ethics, Recusal, and Transparency Act (or SCERT) would require the Supreme Court to establish or adopt a code of ethics including an enforcement mechanism for failures to follow it, a system to determine when conflicts of interest should require recusal from a case, and a financial transparency process equal to that which members of Congress must follow.

Do No Harm Act:

The Do No Harm Act would clarify the meaning and intent of the Religious Freedom Restoration Act (RFRA) to prevent the courts from allowing discrimination based on religion in health care, social services, employee benefits, and other areas.

The Information Quality Assurance Act:

The Information Quality Assurance Act directs federal agencies to rely on the best reasonably available scientific, technical, demographic, economic, and statistical information and evidence when writing the federal regulations that detail how federal laws will be carried out. This “good government” bill helps ensure that religious beliefs will not influence regulations covering faith-based institutions that provide social services, for example.

The Preventing Private Paramilitary Activity Act :

The Preventing Private Paramilitary Activity Act would provide restrictions on the type of activities militias can do without infringing on Second or First Amendment rights. Militias are known to be populated with Christian nationalists who may be motivated to take action to implement their vision of what the government and society should look like.

The Religious Freedom and Fairness Act:

The Religious Freedom and Fairness Act would “prevent preferential treatment for atheist groups,” a non-issue that was blown out of proportion when a group in Nepal received federal funds to help people of various faiths and atheists who were being persecuted by the government.

The Conscience Protection Act:

The Conscience Protection Act would allow hospitals, doctors, nurses, orderlies, and even insurance companies to cite their personal religious beliefs in order to deny a patient care. It would also prohibit “discrimination” in federal programs against health care facilities that do not provide abortions. Religion should never be allowed as a reason to refuse to provide necessary medical care.
