The Do No Harm Act:

The Do No Harm Act would clarify the meaning and intent of the Religious Freedom Restoration Act (RFRA) to prevent the courts from allowing discrimination based on religion in health care, social services, employee benefits, and other areas.

<u>The Supreme Court Ethics, Recusal and Transparency</u> <u>Act</u> (<u>SCERT):</u>

The Supreme Court Ethics, Recusal, and Transparency Act (or SCERT) would require the Supreme Court to establish or adopt a code of ethics including an enforcement mechanism for failures to follow it, a system to determine when conflicts of interest should require recusal from a case, and a financial transparency process equal to that which members of Congress must follow.

The Therapeutic Fraud Prevention Act:

The Therapeutic Fraud Prevention Act would establish that conversion therapy is a fraudulent business practice because it does not work and can cause harm, and provides that any licensed therapist using it would lose their license to practice. Conversion therapy is the discredited practice, often motivated by religious beliefs, of attempting to change a person's sexual identity with <u>psychoanalysis</u>, behavior modification, or mental health counseling.

The Conscience Protection Act:

The Conscience Protection Act would allow hospitals, doctors, nurses, orderlies, and even insurance companies to cite their personal religious beliefs in order to deny a patient care. It would also prohibit "discrimination" in federal programs against health care facilities that do not provide abortions. Religion should never be allowed as a reason to refuse to provide necessary medical care.

The Religious Education Week Resolution:

The Religious Education Week Resolution calls on states to accommodate individuals who wish to be released from public school attendance to attend religious classes, which it says 540,000 public school students now do each year.

The Safeguarding Charity Act

The Safeguarding Charity Act would override court decisions which found that faith-based high schools and other faith-based organizations and churches are recipients of federal funding by way of their nonprofit tax status, and are therefore not exempt from federal nondiscrimination requirements.
